GREENE COUNTY CONSERVATION DISTRICT REGULAR MEETING MINUTES January 16, 2024

CALL TO ORDER AND INTRODUCTION OF GUESTS

Mr. James A. Cowell, Jr. called the meeting to order at 10:05 a.m. at Greene County Fairgrounds Building 10, 107 Fairgrounds Road, Waynesburg, PA.

OATH OF OFFICE

Commissioner Edgreen administered the Oath of Office to Greg Hopkins, Farmer Director, term to expire December 31, 2027 and Rebecca Trigger, Public Director, term to expire December 31, 2027.

Ms. Snider asked for nominations for Chairman of the Greene County Conservation District Board.

A motion was made by Greg Hopkins to nominate James Cowell, Jr. as Chairman of the Conservation District Board. Dan Bazzoli seconded. (Motion Passed)

Ms. Snider turned the meeting over to the newly appointed Chairman, Mr. James Cowell, Jr.

A motion was made by Dan Bazzoli to nominate Greg Hopkins as Vice-Chairman of the Greene County Conservation District Board. Rebecca Trigger seconded. (Motion Passed)

A motion was made by Greg Hopkins to nominate Dan Bazzoli as Treasurer of the Greene County Conservation District Board. Rebecca Trigger seconded. (Motion Passed)

A motion was made by Greg Hopkins to nominate Glodenna Halstead as Secretary of the Greene County Conservation District Board. Rebecca Trigger seconded. (Motion Passed)

PUBLIC COMMENTS

There were no public comments.

APPROVAL OF MINUTES

A motion was made by Dan Bazzoli to approve November 21, 2023 minutes. Rebecca Trigger seconded. (Motion Passed)

TREASURER'S REPORT

Ms. Yorko distributed an updated Treasurer's Report to the board before the start of the meeting. Ms. Yorko explained that there had been an Account Receivable Specialist hired in the Controller's office so they were working together to get all county invoices current. The updated Treasurer's Report includes a check to the County of Greene for \$76,665.37 and two other checks to transfer funds from First Federal General Fund to the Dirt & Gravel and Low Volume Road accounts.

A motion was made by Greg Hopkins to approve the treasurer's report. Dan Bazzoli seconded. (Motion Passed)

REQUEST FOR ADDITIONAL AGENDA ITEM

There was no request for additional agenda items.

CORRESPONDENCES AND UPCOMING EVENTS

March 13th Hay Meeting with Penn State Extension from 6-8:30 at the Greene Couty Fairgrounds Building 10 Upstairs. Ms. Prochaska placed an ad for the next issue of the Greene Saver; additionally, there will be a press release close to the event.

Ms. Snider received an email regarding the West Nile Virus Grant award \$29,194.00, Mr. Cowell and Mr. Hopkins will be receiving emails to sign online for the grant. Mr. Hopkins asked if the West Nile Virus grant have been cut and Ms. Snider explained that they cut our tire recycling/habitat reduction amount; however, the board voted to match the funds at the last meeting, giving the district approximately \$5,000 for tire recycling.

Mr. Brakenrich emailed that there is a pesticide update class for 2 core and 2 category credits on January 24th from 1-3 at Greene County Fairgrounds Building 10.

A private applicator short course – prep class for anyone that would like to take exam to get private license will be offered January 31^{st} and February 1^{st} from 9-3.

STAFF REPORTS

Written reports were included in the meeting packets.

Lindsay Kozlowski – Ms. Kozlowski was unable to attend due to Wisecarver Progress meeting at the same time.

Zack Basinger – Mr. Basinger was unable to attend due to Wisecarver Progress Meeting at the same time.

Tiffany Stewart – Ms. Stewart stated that she had her final walk through at the Willis Farm and she is preparing to submit the final report closing the Willis Growing Greener Grant.

At Cree Farm the Growing Greener Grant dairy cattle portion is done and work will begin on the beef cattle portion in the spring.

Cree Farm ACAP is 95 percent complete, they are just waiting to get the roof gutters installed and inspected by NRCS.

Ms. Stewart was finally able to get a hold of the landowner's son regarding the Jefferson Bridge site and she is working on getting written approval of a landowner agreement.

Tess Prochaska—Ms. Prochaska stated that she reviewed Conrad Gall's manure management plan which had some issues including that it is mostly illegible. Ms. Prochaska, Mr. Basinger and Ms. Snider are meeting with Paul Cinkan of DEP on Friday, January 19th in the office and then going to meet with Mr. Gall at his farm.

Heather Yorko – Ms. Yorko didn't have much to add to her written report, just that the new person for the County in Accounts Receivable was getting settled and that she felt invoice billing would go smoothly going forward.

Mr. Basinger has a permit for a stream crossing that they need to review with Mr. Gall as well as the manure management plan. DEP had requested that they meet on the farm so they have that planned for this Friday.

UPDATE AND APPROVAL OF FINANCIAL SIGNATORIES AND BONDING

Ms. Snider stated that the board needs to make a decision regarding who is going to have signing powers for all the banks. At this moment, only Mr. Cowell and Mr. Hopkins are able to sign district checks.

Mr. Cowell recommended that the Commissioner Representative be given signing power since it is a short trip across the street for Ms. Yorko to get one of the needed signatures which is easier than two other members trying to make trips to the district office.

Ms. Snider informed the board that if they chose to add the Executive Board Members and the Commissioner Representative, they would be a slight increase in the bonding fees due to having five signatories.

A motion was made by Greg Hopkins to nominate Commissioner Edgreen as one of the GCCD signatories, contingent on the Greene County Commissioners deciding that Commissioner Edgreen be the Commissioners Representative, along with the Executive Board Members. Glodenna Halstead seconded. (Motion Passed)

Ms. Snider stated that all 2023 Associate Board members had expressed their willingness to continue in 2024 and that the Commissioner had not sent any new names for associate directors. This form is utilized annually to verify the donation of mileage to Envirothon by those board members that choose to do so. Board members were asked to update the contact information and return forms to Ms. Yorko as soon as possible.

2024 BUDGET REVIEW

Ms. Snider explained that she reviewed the 2024 Budget with Commissioner Belding and Mr. Hopkins in December and she had only made one big change pertaining to ACAP; ACAP Professional Service amount adjusted due to it covering three years and wanting to use funds for engineering assistance.

A motion was made by Dan Bazzoli to approve the 2024 Budget. Rebecca Trigger seconded. (Motion Passed)

APPROVAL TO ADVERTISE FOR REQUESTS FOR PROPOSALS AND QUALIFICATIONS FOR ENGINEERING ASSISTANCE FOR ACAP

Ms. Snider explained that regarding the ACAP Program the conservation district is finding it difficult to find engineering services for the landowners to get applications put together, to do the work on the farm when construction is taking place, and to certify the practices that need to be certified. The district staff does not have an engineering background so we need to hire outside agencies to assist. Most other counties are hiring an engineering firm and utilizing their technical service funds through ACAP which is 14 percent of ACAP award. These companies are working for the conservation district to help put together applications, be out in the field be sure that the practices are being installed correctly and certify those practices. Having the engineering firm working for the Conservation District instead of the landowner would allow Ms. Snider to make sure that bids are put together properly, have everything advertised according to the county's policy, prevailing wages are accounted for in securing services and things are done correctly.

Ms. Snider put together an advertisement for Request for Qualifications and Proposals to see if we can get an engineering company.

A motion was made by Rebecca Trigger to advertise for engineer for ACAP Program. Glodenna Halstead seconded. (Motion Passed)

2024 GRACE PROGRAM APPLICATION ADVERTISEMENT

Ms. Snider is ready to advertise for the 2024 GRACE Program, just needs the approval of the board to place the ad.

Ms. Snider stated that she added staff members to the committees as needed and that we need a board member for Dirt and Gravel Roads to replace Bill Wentzel. The Dirt and Gravel Road person can expect to spend two days out in the field doing QAB ranking.

After discussion, the decision was made to make George Scull a voting member on the Dirt and Gravel Road Committee.

NUTRIENT MANAGEMENT SPECIALIST

Ms. Snider stated that she thought it was time to advertise for a Nutrient Management person or another option would be to share a position/cost share with Washington County for Nutrient Management. There is about two years of trainings involved in getting certified in Nutrient Management and it is not feasible to send Ms. Prochaska to these trainings, because she would be out of the office for training during the busiest part of the year with GRACE and ACAP. Glodenna Halstead mentioned that she knows someone that may be interested if we decided to hire a Nutrient Management Specialist.

A motion was made by Dan Bazzoli to advertise for a Nutrient Management Specialist. Glodenna Halstead seconded. (Motion Passed)
