INVOCATION-

MINUTES- Approve the October 10, 2024 meeting minutes.

PROCLAMATIONS

- 1) Approve a Proclamation for October 2024 to be recognized as Local Chamber of Commerce Month.

COMMISSIONERS FINANCE & ADMINISTRATION

- 1) Approve a right of way settlement documents between the County of Greene and CNX Land LLC. This is for parcel#2 for bridge#75 replacement project. Amount is \$506.00 per PennDOT Guidelines and designate Jeffrey Marshall, Chief Clerk as signatory on these bridge documents.
- 2) Approve a proposal from Widmer Engineering for the design, permitting, right of way, and the bid package for the replacement of bridge #7 in Perry Township. Cost of proposal is \$332,968.08 and will be paid for with PennDOT grant and liquid fuel funds. Designate Jeffrey Marshall, Chief Clerk, as signatory on bridge documents.
- 3) Approve the re-appointment of Darla Openbrier, District Administrator of the Washington Office of Vocational

Rehabilitation, to the Southwest Corner Workforce Development Board.

- 4) Approve to reject bids received in response to the Request for Proposal for the Greene County Fairgrounds Grandstand Lighting Project and authorize Chief Clerk to rebid the project.

- 7) Approve a supplemental agreement from Widmer engineering for County Bridge 103 and Phase 1A and 1B, cost \$17,500 using PennDot funds.
